<b>1</b>	<b>Nature of the tasks:</b>
<p>Our unit enforces EU competition law (in particular Articles 101 and 102 TFEU) in media, a fast-moving sector of the digital economy, key to Europe's growth. Main issues currently being dealt with by the unit include, among others, restrictions on cross-border access to pay-TV, most favoured nation clauses in e-book publishing and digital broadcasting. In addition, we closely follow legislative projects of relevance to our sector and contribute to forming the Commission position on the regulatory aspects of intellectual property (copyright) and audio-visual policies.</p> <p>We offer a highly interesting and rewarding case-handler position in a dedicated team dealing with cutting-edge legal and economic issues. As a case-handler, you will work together with other case team members on a number of cases and will potentially deal with every stage in the procedure, from the initial investigation until the adoption of a formal Commission decision. The work may also involve participation in working groups on procedures, policy issues and legislation as well as drafting of speeches and briefings.</p> <p>The position involves frequent contacts with companies and their advisors, other DGs, in particular DG CNECT, DG GROW and DG EAC, and with national competition authorities actively enforcing competition rules in the media sector.</p> <p>The work of the unit is highly diverse and stimulating, there is a friendly and team-oriented working atmosphere and we promote family-friendly working conditions.</p>

<b>2</b>	<p><b>Main qualifications:</b></p> <p>a) Eligibility criteria</p> <p>The following eligibility criteria are to be fulfilled by the candidate in order to be seconded to the Commission. Consequently, the candidate who does not fulfil one of them will be automatically eliminated from the selection process.</p> <ul style="list-style-type: none"> <li>• Professional experience: at least three years' experience in administrative, legal, scientific, technical, advisory or supervisory functions which can be regarded as equivalent to those of function groups AD;</li> <li>• Seniority: at least one year by your employer, that is having worked for an eligible employer (as described in Art. 1 of the SNE decision) on a permanent or contract basis for at least 12 months before the secondment;</li> <li>• Linguistic skills: thorough knowledge of one of the EU languages and a satisfactory knowledge of another EU language to the extent necessary for the performance of the duties. An SNE from a non-member country must produce evidence of a thorough knowledge of one EU language necessary for the performance of his duties.</li> </ul> <p>b) Selection criteria</p> <ul style="list-style-type: none"> <li>- Diploma: University degree, preferably in law or economics.</li> <li>- Professional experience in and/or knowledge of competition and intellectual property law will be an advantage, as may be experience in the media and/or publishing industry.</li> <li>- Language(s) necessary for the performance of duties: An excellent knowledge of English is essential including proven ability to draft in English. A good working knowledge of French and/or German would be an advantage.</li> </ul>
<b>3</b>	<p><b>Submission of applications and selection procedure</b></p> <p>Candidates should send their application according to the <b>Europass CV format</b> (<a href="http://europass.cedefop.europa.eu/en/documents/curriculum-vitae">http://europass.cedefop.europa.eu/en/documents/curriculum-vitae</a>) in English, French or German <b><u>only to the Permanent Representation / Diplomatic Mission to the EU of their country</u></b>, which will forward the applications to the competent services of the Commission within the deadline fixed by the latter. <b>Not respecting this procedure or deadlines will automatically invalidate the application.</b> <b>Candidates are required not to add other documents</b> (such as copy of passport, copy of degrees or certificate of professional experience, etc). If necessary, these will be requested at a later stage. Candidates will be informed of the follow-up of their application by the unit concerned.</p>
<b>4</b>	<p><b>Conditions of the secondment</b></p> <p>The secondment will be governed by the <b>Commission Decision C(2008)6866 of 12/11/2008</b> laying down rules on the secondment to the Commission of national experts and national experts in professional training (SNE Decision). This decision is available on <a href="http://ec.europa.eu/civil_service/job/sne/index_en.htm">http://ec.europa.eu/civil_service/job/sne/index_en.htm</a>.</p> <p>The SNE will remain employed and remunerated by his/her employer during the secondment. He/she will equally remain covered by the national social security.</p> <p>Unless for cost-free SNEs, allowances may be granted by the Commission to SNEs fulfilling the conditions provided for in Art. 17 of the SNE decision.</p>

During the secondment, SNEs are subject to confidentiality, loyalty and absence of conflict of interest obligations, as provided for in Art. 6 and 7 of the SNE Decision.  
If any document is inexact, incomplete or missing, the secondment may be cancelled.

**5 Processing of personal data**

The selection, secondment and termination of the secondment of a national expert requires the Commission (the competent services of DG HR, DG BUDG, PMO and the DG concerned) to process personal data concerning the person to be seconded, under the responsibility of the Head of Unit of DG HR.B4. The data processing is subject to the SNE Decision as well as the Regulation (EC) No 45/2001 of the European Parliament and of the Council of 18 December 2000 on the protection of individuals with regard to the processing of personal data by the Community institutions and bodies and on the free movement of such data.

Data is kept by the competent services for 10 years after the secondment (2 years for not selected or not seconded experts).

Data subjects may exercise their right of access to data concerning them and the right to rectify such data by applying to the controller, in accordance with Article 13 of the Regulation on the processing of personal data.
