<u>TERM</u>	The screenings shall occur between March 5 th and 8 th , 2022
<u>FEE</u>	Licensee agrees to pay an overall amount of € 600 euros (six hundred) plus 22%, of Vat that amounts to 132,00 (one hundred thirty-two) so the total amount will be € 732,00 net of withholding tax and any other tax, levies, etc. if applicable. Such fee shall be paid by Licensee to Vision Distribution as follows: 100% upon receipt of electronic invoice, only to the Licensor's bank account: IBAN: IT60T0200805364000104600608 BIC/SWIFT UNCRITMMORR.
