
Activities and Services

Introduction

This chapter gathers some statistics into a quantitative illustration of the various sectors of the Ministry's activities: International affairs, Cultural sector, Italians abroad, Visa service, Official Development Assistance, Communication and information, Trade and investment promotion.

The **International affairs** section contains data on visits by Heads of State and Government to Italy and those of the President of the Republic, the Prime Minister and the Minister for Foreign Affairs abroad. It refers also to the international Agreements concluded by Italy and other activities carried out by the Diplomatic Legal Advisory Service. One table presents data on foreign debt cancelled by Italy for HIPC (Heavily Indebted Poor Countries).

Figure 2.1 – Visits and international meetings (2002-2004)




The **Cultural sector** section contains data regarding Italian schools and Chairs abroad and scholarships awarded by the Directorate General for Cultural Promotion and Cooperation. In the context of the activities in the course of 2004 related to the diffusion of Italian Language and Culture in the World, it is interesting to note an increase of 6.5% from one academic year to another.

The **Italians abroad** section contains data on consular registry, main consular service and prisoners held abroad.

As of 31st December 2004 a total of 4 026 125 Italian citizens residing abroad were enrolled in consular reflecting a slight rise of 1.0% as compared with 2003.


It is interesting to note how interventions by the Ministry's Crisis Unit on behalf of Italian nationals in emergency situations increased in 2004 (Fig. 2.2):

Figure 2.2 – Italians abroad: interventions by the Ministry's Crisis Unit on behalf of Italian nationals in emergency situations (2004)




Among the main consular and administrative services (Fig. 2.3) only the passports shows a growth on the previous year:

Figure 2.3 – Main consular and administrative services (2000-2004)




The **Visa service** section contains detailed data on visas by geographical area and type. In 2004 a total of 983 499 visas to enter Italy were issued by authorised Italian representations. Figure 2.4 shows % distribution by geographical area.


Figure 2.5 – Visas to enter Italy by purpose (2004)

Of all visas issued in 2004, 48% were for purposes of tourism, 13% for business, 7% for transit and for dependent employment and 8% for family reunion (Fig. 2.5).


An important result is the growth of applications for Africa, in which Italy is interested in (Fig. 2.6):

Figure 2.6 - Official Development Assistance Commitments (grants and loans in % by geographical area)





The **Trade and investment promotion** section contains data regarding the facilities located abroad that are specifically dedicated to the treatment of economic and trade issues, to the promotion of the *Made in Italy* label and to support for Italian businesses abroad.

Particularly interesting are the data concerning the pilot "*MFA-ICE sportelli*": a new approach to the logistical-functional integration of existing institutions, created with the specific objective of strengthening governmental support of the internationalisation of Italian businesses.
