
Activities and Services

Introduction

This chapter gathers some statistics into a quantitative illustration of the various sectors of the Ministry's activities: International Affairs, Cultural sector, Italians abroad, Visa Service, Official Development Assistance, Communication and Information. Also included are data concerning the Commercial Offices, the Italian Chamber of Commerce and the events of the Italian Presidency of the Council of the European Union (July-December 2003).

The **International Affairs** section contains data on visits by Heads of State and Government to Italy and those of the President of the Republic, the Prime Minister and the Minister for Foreign Affairs abroad. It refers also to the international Agreements concluded by Italy and other activities carried out by the Diplomatic Legal Advisory Service. One table presents data on foreign debt cancelled by Italy for HIPC (Heavily Indebted Poor Countries).

Figure 2.1 – Visits abroad of the President of the Republic, the Prime Minister and the Minister for Foreign Affairs (2000-2003)




The **Cultural sector** section contains data regarding Italian schools and Chairs abroad and scholarships awarded by the Directorate General for Cultural Promotion and Cooperation. In the context of the activities in the course of 2003 related to the diffusion of Italian Language and Culture in the World, it is interesting to note the data on Italian courses in local public schools:

- ◆ the offering of no less than 12 653 Italian language courses and the teaching of Italian in 15 541 local public schools;
- ◆ the students attending these language courses numbered 156 293 and the persons studying Italian in local public schools 325 314.


Regarding the Italian schools abroad (Fig. 2.2) in 2003, the situation was very similar to the previous year: 164 schools in the 2003/2004 academic year as compared with 171 in the 2002/2003 academic year. The number of students remains practically stable from one academic year to another.


Figure 2.3 – Italians enrolled in consular registries: distribution by geographical area (as of 31 December 2003)

The **Italians abroad** section contains data on consular registry and main consular services. As of 31 December 2003 a total of 3 985 040 Italian citizens residing abroad were enrolled in consular registries with a slight rise of 0.5% as compared with 2002. More than half of all Italians residing abroad (Fig. 2.3) reside in European countries. This is a well-established situation and not comparable to the heavy influxes that characterised many of the decades of the last century.

The most populated Italian communities (Fig. 2.4) reside respectively in Germany (18% of the total with a predominantly male population) Argentina (15% of the total with a predominantly female population) and Switzerland (13% of the total with a predominantly male population).


It should be noted that 93% of Italians residing abroad are concentrated in only 15 countries while 35% are enrolled in 11 consular districts first among which is that of Buenos Aires (resident population 259 555).

Figure 2.4 – Main consular districts (as of 31st December 2003)




The main consular and administrative services (Fig. 2.5): certificates of birth, death and marriage and also citizenship acts showed a sharp increase in 2003 compared with the previous year: 35% respectively and 43%.

Figure 2.5 – Main consular and administrative services (2000-2003)




The **Visa Service** section contains detailed data on visas by geographical area and type. In 2003 a total of 874 874 visas to enter Italy were issued by authorised Italian representations. Figure 2.6 shows % distribution by geographical area.

Figure 2.6 – Visas to enter Italy subdivided by geographical area (2003)




Of all visas issued in 2003, 45% were for purposes of tourism, 14% for business, 9% for transit and for dependent employment and 8% for family reunion (Fig. 2.7).

The **Official Development Assistance** section contains data on ODA by geographical area and to major recipients. The Ministry of Foreign Affairs promotes and coordinates development cooperation initiatives. It administers approximately one-third of the overall Italian ODA in the form of donations, credit assistance and food aid. The remaining portion of the ODA Funds (made up of transfers to the EU, reconstitution of bank and development fund capital) is administered by the Ministry of Economy and Finance. Underlined also should be the importance of the Rotating Fund for credit assistance at the Mediocredito Centrale.
