To have not tested positive for the coronavirus or, if tested positive in an RT PCR test carried out abroad, to have scrupulously followed the health protocols laid down by the authorities of the country where the test was carried out, to have observed 14 days of isolation since the last date of symptoms and to be no longer subject to quarantine measures by the local authorities;
