ORDINANCE OF 21 September 2020.

Further urgent measures for controlling and managing the COVID-19 epidemiological emergency.

THE MINISTER OF HEALTH

(Preamble omitted)

The following ordinance IS ISSUED:

Article 1.

Urgent measures to control and manage the health emergency

- 1. For the purpose of controlling the spread of the COVID-19 virus, the following change is made to Article 1, paragraph 1, of the Ordinance by the Minister of Health of 12 August 2020, which was extended and supplemented with the decree made by the President of the Council of Ministers on 7 September 2020. The words "Croatia, Greece, Malta or Spain" are replaced by the following: "Croatia, France (limited to the regions of Auvergne-Rhône-Alpes, Corsica, Hauts-de-France, Île-de-France, Nouvelle Aquitaine, Occitanie, Provence-Alpes-Côte d'Azur), Greece, Malta or Spain".
- 2. For French territories other than those indicated in paragraph 1, the provisions set out in the decree by the President of the Council of Ministers made on 7 August 2020 remain in place. Any extension or supplementation of the aforementioned decree also remain in place.
- 3. The following provisions shall also apply to persons who may intend to enter Italy after having stayed or transited through the following States and territories in order to adapt to the current epidemiological situation and control the spread of COVID-19:
- *a)* From Bulgaria: persons follow the provisions for the countries indicated in List B of Annex 20 accompanying the Decree by the President of the Council of Ministers of 7 August 2020;
- b) From Serbia: persons follow the provisions for the countries indicated in List E of Annex 20 accompanying the Decree by the President of the Council of Ministers of 7 August 2020.

Article 2.

(Final provisions)

1. This Ordinance is in force from the day following its publication in the *Official Gazzete* of the Italian Republic and will stay in force until the adoption of

- of any subsequent decree by the President of the Council of Ministers, pursuant to Article 2, paragraph 1, of the Decree-Law of 25 March 2020, No. 6, which was converted into law with some modifications by the Law of 5 March 2020, No. 35. Otherwise, it will in any case remain in force only until 7 October 2020.
- 2. The provisions of this current ordinance are applicable to the special status Regions and the autonomous Provinces of Trento and Bolzano when in accordance with their respective statutes and related implementation standards.

The current ordinance is being forwarded to the competent supervisory bodies for registration and publication in the *Official Gazette* of the Italian Republic.
