The European Maritime Safety Agency is one of the European Union's decentralised agencies. Based in Lisbon, the Agency provides technical, operational and scientific assistance to the European Commission and Member States in the fields of maritime safety, maritime security, prevention of, and response to, pollution caused by ships as well as response to marine pollution caused by oil and gas installations. The Agency also contributes to the overall efficiency of maritime traffic and maritime transport and supports European cooperation on coastguard functions.

EMSA invites you to send your application for a Seconded National Expert as a Project Officer for accident investigation. This position will be attached to Department B 'Safety & Standards', in Unit B.2 'Ship Safety' in the 'Accident Investigation' Section.

Functions and Duties:

Under the responsibility of the Head of Unit B.2. 'Ship Safety', the successful candidate will assist in the following duties:

- Analysing marine casualties and investigation reports and advising on best practices;
- Developing and delivery trainings for accident investigators;
- Participating in the enhancement of the new EMCIP;
- Supporting the operation of the new EMCIP;
- Supporting the implementation of operational support to Member States in the investigation of very serious and serious casualties;
- Assisting in the conduct of any other activity EMSA may be tasked with in the field of accident investigation.

Main skills and qualifications:

- A university degree or equivalent qualification or professional experience;
- At least three years of experience as a marine accident investigator having worked on safety investigations in an accident investigation body or maritime administration experience related to safety activities (i.e. Flag State surveyor, Port State Control officer, other similar duties in the maritime safety sector), acquired after the award of the required qualification. If no university degree or equivalent qualification has been acquired, seven years of relevant experience is required, of which three must be within an accident investigation body or maritime administration;
- Thorough knowledge of legislation and instruments related to marine casualties (SOLAS, IMO Code of Incident Investigation, the EU Directive establishing the fundamental principles governing the investigation of accidents in maritime transport);
- Good level of written and spoken English.
- Experience in conducting marine casualty investigation will be considered advantageous;
- Experience with casualty analysis will be considered advantageous;
- Good knowledge of EMCIP platform will be considered advantageous;
- Experience in development, monitoring and operation of IT systems will be considered advantageous;
- Experience with preparation and delivery of training will be considered advantageous.
