#### 2. Objectives

- **2.1 Overall Objective(s):** To improve the national policy in the area of market policy, structural activities and state aid in accordance with EU acquis for Fisheries and Aquaculture sector in North Macedonia.
- **2.2 Specific objective:** To strengthen the capacities of the Ministry of Agriculture, Forestry and Water Economy (MAFWE) and other stakeholders in view of aligning the legal framework in the market policy, structural activities and state aid in the fisheries sector with the Union *acquis*.

### 2.3 The elements targeted in strategic documents i.e. National Development Plan/Cooperation agreement/Association Agreement/Sector reform strategy and related **Action Plans**

Overall, the National Strategy for Agriculture and Rural Development 2021-2027 prioritises the harmonization of legal framework with the Union acquis in the area of Agriculture and Rural Development. However, there is no specific strategic document for fisheries and aquaculture. The legal and institutional alignment of the sector is according to the National Plan for the Adoption of the Acquis (NPAA). Specific development objectives and actions for fisheries and aquaculture development are mapped in the "Programme for fisheries and aquaculture development for period 2013-2024"6.

In addition, this project will contribute to the Public Administration Reform Strategy 2018 - 2022 to achieve the goals defined in the priority area Policy-making and Coordination between Government's institutions with regard to the legal framework, the organizational setup and capacities of the institutions, as well as the human resource capacities in the public administration. The project proposed under this fiche aims to support the Beneficiary Institutions, through assistance in the process of legal and administrative harmonization with the Union acquis in the field of Fisheries.

#### EC Progress Report North Macedonia 2020

In Chapter 13: Fisheries of the European Commission's Progress Report<sup>7</sup> concerning North Macedonia it is stated that: "North Macedonia continues to be **moderately prepared** in this area. No progress was made on last year's recommendation to further align market policy with the acquis. In the coming year, the country should further align its legislation with the acquis and ensure its implementation and enforcement, in particular for illegal, unreported and unregulated fishing, data collection, structural support and state aid."

#### National Plan for the Adoption of the Acquis (NPAA) 2021-2023

The Document defines development and strategic goals, relevant policy reforms and measures required for the realization of these goals, establish a detailed plan for harmonization of legislation and define human and budget resources, as well as other funds required for the implementation of envisaged tasks.

In the section 3.13 Fisheries it is planned preparation of new Law on fisheries and aquaculture for 4<sup>th</sup> quarter of 2021. With the new Law, MAFWE's intention is to set up the base to fulfill the EU requirements in the field of Fisheries and Aquaculture. Aligning the national legislation with the Union acquis in the field of fisheries is a priority for MAFWE and North Macedonia. This also

facilitates the appearance and creation of opportunities for effective monitoring of fishery and aquaculture products.

According to the NPAA 2021-2023 the following activities are planned in the period 2021 - 2023 by MAFWE in the sector of Fisheries:

- NPAA 2021 - Preparation of the new Law for Fisheries and aquaculture. – The relevant parts from Regulation (EU) No 1380/2013 of the European Parliament and of the Council of 11 December 2013 on the Common Fisheries Policy, defines areas included in Common Fisheries Policy and Council Regulation (EC) No 1379/2013 of the European Parliament and of the Council of 11 December 2013 on the common organisation of the markets in fishery and aquaculture products will be aligned in the new Law on Fisheries and Aquaculture, Council Regulation (EC) No 1224/2009 of 20 November 2009 establishing a Community control system for ensuring compliance with the rules of the common fisheries policy defines inspection and control of fisheries activities.

- 3. Description
- 3.1 Background and justification:
- a) Background

Fisheries and aquaculture

The Republic of North Macedonia is a land-locked country and has neither any marine fisheries activities nor any fishing vessels operating at sea under the North Macedonia flag. North Macedonia has a 56.000 ha of water resources. 46.700 ha of these are natural lakes surfaces, 6 400 ha artificial lakes, 2.200 ha rivers and around 700 ha fish ponds. The water surfaces are used for recreational and for commercial fishing on the natural lakes (Ohrid, Prespa and Dojran Lake) and two artificial lakes (Tikves and Spilje Lake). The right to organize recreational and commercial fishing is given to entities by Competitive Public Call for the period of 6 years.

Aquaculture is allowed to the entities which are registered in the Register of fish breeders within the MAFWE according the provisions of the Law on Fisheries and Aquaculture.

At present, 107 aquaculture facilities have been registered in the register of fish breeders within the Ministry of Agriculture, Forestry and Water Economy (2021). The most common species reared in aquaculture facilities are: Trout (mainly rainbow trout, than brown (river) trout and Ohrid trout in very small quantities) with 63% in total aquaculture production and Carp with 34% of total aquaculture production. Around 96 – 97 % of total fish production is from aquaculture and only 3-4% is from catch of commercial fishing. Very simple equipped boats with an average length of four meters are used for commercial fishing in the lakes. Aquaculture and fresh water fisheries provide employment for 434 persons and contribute 0.1 % to the national gross value added. The number of recreational fisher in 2020 was 13,003.

Detailed export and import data will be presented to Member State(s) Twinning Light Partners by the Beneficiary Country administration upon request.

#### Institutional framework

The Ministry of Agriculture, Forestry and Water Economy (MAFWE) holds the mandate for fisheries and aquaculture policy and implementation. MAFWE holds a Unit for Fisheries and Aquaculture into Agriculture Department that is dedicated specifically to the following tasks: preparing, proposing and implementing legal acts in respect to fisheries and aquaculture, preparing the Annual Programs for financial support, as well as the managerial and technical issues in the fisheries area such as: procedures for gaining the concessions for commercial and recreational fishery, managing permits and licenses and approval of yearly plans of subjects - responsible for organizing the recreational and commercial fishery. The Unit for Fisheries and Aquaculture receive daily data on commercial catch and yearly on aquaculture for produced fish, maintains records for concessionaires as well as the data for anglers and the quantity of fish caught by recreational fishing, register the entities with permits for production of reproductive materials, data base for fish pond breeders and conducts register of fish breeders, repro/centers and producer organizations.

The **State Agriculture Inspectorate** (SAI) performs inspection and control activities related to fisheries and aquaculture through the Department for inspection control in the area of fisheries and aquaculture, livestock and apiculture, cereals and land management, where two units are directly responsible for the fisheries area: Unit for inspection controls in the area of fisheries and aquaculture

with 8 employees (6 state inspectors for fisheries and aquaculture) and Unit for physical protection of fishing waters with 9 employees (3 consultants and 6 fish protection officers).

The **Agency for Financial Support of Agriculture and Rural Development** (AFSARD) beside the support of Agriculture and Rural Development provides implementation of the measures planned for fisheries policy conduct public calls regarding Program for Fisheries and Aquaculture, administrative and on the spot control as well as payment.

The **Food and Veterinary Agency** (**FVA**) is the competent authority for animal health protection of aquatic animals, primary production, placing on the market of fish and aquatic animals, hygiene requirements for fish and aquaculture, registration of fish farms, registration of processing establishments for food of animal origin, import and export of fish, aquaculture and products thereof.

The Ministry of Environmental and Physical Planning (MoEPP) beside other responsibilities, in the fisheries area is responsible for nature and biodiversity protection and regulates the use of alien and locally absent species. In addition, MoEPP is responsible for water use licensing of aquaculture producers.

Three **Scientific institutions** (Institute for Animal Science - Skopje, Hidrobiological Institute - Ohrid and Faculty of Veterinary Medicine) are authorized for scientific issues related to Fisheries and Aquaculture. The scientific institutions in the fisheries area are involved in implementation of fish stocking measures and in preparation of the Fishing Master Plans.

The **State Statistical Office** (SSO) in accordance with State Statistics Act and Five-annual programme for statistical surveys is in charge for data collection, processing, analysis and publishing fishery statistics. Data for fishery statistics are collected by entities, who are dealing with fishery. In accordance with organizational rules in SSO: the design of questionnaire and methodology, data checking, data processing, analysis and publishing data are under the competence of Department for agriculture, forestry and fishery statistics. The data collection and first check of data is done in 8 regional statistical offices.

#### Legal framework

The main legislative act is the Law on Fisheries and Aquaculture and its bylaws. Other legal acts linked with the market, inspection and control and structural support in fisheries and aquaculture are listed in the Annex 2 of this Twinning Fiche.

#### b) Justification

The "Programme for fisheries and aquaculture development for period 2013-2024" represents "National multiannual strategic plan for fisheries and aquaculture in North Macedonia" in which the priorities and targets for the development of sustainable fisheries and aquaculture activities are

defined, objectives, measures and the timetables necessary to achieve them. While the programme represents sector economic and social development, the alignment to the EU is mapped in the multi-annual NPAA.

"National Programme for Development of Agriculture and Rural Development for the period 2018-2022" which section for fisheries and aquaculture represents "Operational Programme for the fisheries and aquaculture in North Macedonia". The National programme is implemented through Annual Program for fisheries and aquaculture which is national financial support programme for the implementation the priorities also as set out in the in the Law of Fisheries and aquaculture.

The National Programme for Adoption of the Acquis (NPAA) is a comprehensive long-term document that defines the dynamic of the adoption of the acquis, strategic guidelines, policies, reforms, structures, resources and deadlines to be fulfilled by North Macedonia. Chapter 13 - Fisheries is a part of this document.

The Ministry of Agriculture, Forestry and Water Economy is involved in EU integration process for the Chapters 11, 12 and 13. Legislative (explanatory) meetings for all chapters concerning agriculture – Chapter 11 – Agriculture and Rural development, Chapter 12 – Food safety and Phytosanitary and Chapter 13 – Fisheries have been conducted end of 2019 by EC.

This Twinning Contract is relevant for Chapter 13.

During the Expert mission on Alignment with EU regulation in the area of fishery and aquaculture – North Macedonia 24-28 February 2020 AGR IND/EXP 69066 – TAIEX assistance, expert findings has been reflected positive and being very useful for the preparing request for Twining light, in order to contribute for further alignment with EU acquis. Key expert recommendations are that it is crucial to start developing new law and sub laws as well as to amend the existing legislation in order to set up the new legal frame for market measures and structural support.

Within the scope of the project Nordic Support for Progress of North Macedonia - online workshop, "Summary of the acquis for Chapter 13 Fisheries for countries without access to sea" was held and gap analysis was prepared with recommendations for further alignment as to adopt new Law on fisheries and aquaculture and prepare and adopt separate new legal act for structural support and state aid in fisheries.

North Macedonia being a land-locked country has neither marine fisheries activity nor fishing vessels operating at sea under the North Macedonia flag, therefore substantial parts of the acquis within Chapter 13 Fisheries are not applicable.

Although, the acquis in the Chapter 13 - Fisheries consists of regulations, which do not require transposition into national legislation, still it requires the introduction of measures to prepare the administration and the operators for the implementation of the Common Fisheries Policy (CFP)

rules. Certain measures will however need to be implemented and national legislation adapted to ensure the correct application of the acquis. The relevant acquis are described in the text below.

It should also be noted that North Macedonia is one of the accession countries participating in the European Union strategy of Adriatic Ionian Region (EUSAIR) which promotes cooperation and synergies among the participating EU and non EU countries. One of the flagship priorities of EUSAIR Pillar 1 on Blue Growth, addresses: Promoting Sustainability, Diversification and competitiveness in the fisheries and aquaculture sectors through education, research and technology, administrative, technological and marketing actions, including the promotion of initiatives on marketing standards and healthy environmental habits.

#### Market policy

North Macedonia will need to implement the measures for marketing standards for fisheries products. Existing rules for marketing and labelling of fish and fishery products are only partially aligned with EU requirements. Substantial amendments will be necessary before accession to ensure full alignment. In particular, the marketing standards ought to be defined in line with requirements set in: Council Regulation (EC) No 1379/2013 on the common organisation of the markets in fishery and aquaculture products. For fishery and aquaculture products, in addition to the general requirements for food labelling (EU Food Law requirements), regarding the consumer **information**, additional information for the fish and fisheries products should be prescribed. It is important to transpose the rules related to the marketing standards for fish and fishery products. In order to ensure full alignment with EU legislation it is necessary to adopt substantial amendments to the existing legislative framework for certain fishery products marketing standards (according to Council Regulation (EC) No 2406/96 of 26 November 1996 laying down common marketing standards for certain fishery products). Concerning the applicability of marketing standards for canned fishery products, North Macedonia does not produce canned fish but import these products. The legislation need to be updated concerning the alignment with the relevant EU acquis (Council Regulation (EEC) No 1536/92 of 9 June 1992 laying down common marketing standards for preserved tuna and bonito and Council Regulation (EEC) No 2136/89 of 21 June 1989 laying down common marketing standards for preserved sardines and sardine-type products)

Concerning the producer organization, these are regulated with by the Law on Fisheries and Aquaculture but their registration process needs to be further elaborated to be applicable and in line with the requirements of the **common organisation** of the markets in fishery and aquaculture products (e.g. requirements and criteria for recognition as producer organization and rules for production and marketing plans of PO's) according Council Regulation (EC) No 1379/2013 and Commission Implementing Regulation (EU) No 1419/2013 of 17 December 2013 and Commission Implementing Regulation (EU) No 1418/2013 of 17 December 2013.

For controlling the application of the rules of the CFP at all stages of the marketing of fisheries and aquaculture products according the Council Regulation (EC) No 1224/2009 of 20 November 2009 establishing a Community control system for ensuring compliance with the rules of the common fisheries policy defines inspection and control of fisheries activities the necessary administrative capacity needs to be strengthened and trainings of the inspections staff needs to be ensured.

For the proper implementation of the provisions of this regulation the North Macedonia need to pay attention to implementation of Control Regulation: Commission Implementing Regulation (EU) No 404/2011 of 8 April 2011 laying down detailed rules for the implementation of Council Regulation (EC) No 1224/2009.

Representatives from competent authorities (administration and inspection) and stakeholders from food industry will be informed and trained about and fishery product marketing standards, consumer information and traceability through various workshops.

#### • Structural activities

Currently, North Macedonia provides measures for financial support through the Annual Programme for Financial support in the fisheries and aquaculture. The planned measures and funds needed for the implementation of the measures in the annual program are defined in the National Programme for Development of Agriculture and Rural Development for the period 2018-2022.

The instruments, measures and activities for implementation are under the framework of the "Programme for fisheries and aquaculture development for period 2013-2024". For the fully alignment with the EU acquis it is necessary to adopt new Law according the requirements of the Regulation (EU) 2021/1139 of the European Parliament and of the council of 7 July 2021 establishing the European Maritime, Fisheries and Aquaculture Fund and amending Regulation (EU) 2017/1004.

#### State aid

State aid should be defined in line with requirements set in:

- Fishery and Aquaculture Block Exemption Regulation Commission Regulation (EU) No 1388/2014
- De minimis Regulation Commission Regulation (EU) No 717/2014

North Macedonia need to prepare new law with clear distinction of the state aid in the fisheries sector. There is a need to set up state aid schemes registration, control and notification system.

The proposed project should prepare the fisheries sector of North Macedonia in view of future EU accession.

This Twinning project is expected to achieve the results and implement activities according as outlined in sections 3.5 and 3.6.

#### 3.2 Ongoing reforms:

Main Regulation (EU) No 1380/2013 on the Common Fisheries Policy (CFP), should ensure that fishing and aquaculture activities contribute to long-term environmental, economic, and social sustainability. Regulation 1380/2013 also defines the reformed Common Fisheries Policy with great emphasis on the issues of monitoring, control and surveillance, data collection and the combat of the illegal, unregulated and unreported fishing.

Under the structural policy pillar of the CFP, fisheries sector is supported under the European Maritime and Fisheries Fund (EMFF) in order to create a more competitive, environmentally sustainable fisheries sector and provide a better life for the fishing communities in line with the priority axes defined by the EU.

North Macedonia aims to achieve full harmonisation of the national structural policy and state aid with CFP.

With regard to the marketing policy framework of the CFP, common rules are implemented such as marketing standards for fishery and aquacultural products, market measures and recognition of fisheries producer organizations. EU marketing standards define specific quality requirements for EU and non-EU fishery products that are placed on the EU internal market—covering freshness and size categories—and specific labelling requirements that go beyond those required for other food products, for example the obligation to indicate the catch area and the main fishing gear used.

As regards to implementation of EU market measures, producer organizations play a significant role particularly on fisheries management. On the other hand, the EU fishing industry now has greater responsibility in the management of supply and demand. The submission of yearly production and marketing plans has become an obligation for all recognised producer organisations.

The current marketing standards cover some fresh and chilled products, preserved tuna and bonito and preserved sardines and sardine-like products.

In order to approximate towards the CFP reforms, North Macedonia has been preparing a new Law on Fisheries and Aquaculture, besides other areas, the focus is on alignment of the origin, marketing standards in the fishery and aquaculture sector and consumer information as a tool to ensure supply of sustainable products to the market, fair competition among operators and improved profitability of the fishery sector as well as a level-playing field between domestic and imported products with particular emphasis of the products coming from the EU as according to the trade agreement under the Stabilization and Association Agreement (SAA).

This project, therefore, aims to follow the CFP framework to improve the long term institutional and stakeholder capacity for implementation of newly adopted and amended legislation.

The Twinning should help the beneficiaries in the revision of the current national legislative and draft the legal acts aligned with EU requirements. The twinning partners shall support the national authorities in strengthening their capacities to implement the aligned legislation.

#### 3.3 Linked activities:

This project will be the first comprehensive IPA project related to the issues in the field of Fisheries. Nevertheless the following assistance was provided to the competent authorities in the previous period in the area of Fisheries as part of:

MAFWE was subject to Functional Review, financed by IPA and implemented by World Bank. The implementation of the recommendations from this functional review are about to be implemented with the support of the ongoing project IPA funded project "Support to state reorganisation", in the Ministry of Information Society and Administration (MIOA).

Fisheries functions were not subject of the functional review of MAFWE. Therefore, the Twining Project is expected to contribute in this respect.

#### 5.2 Institutional framework

The project beneficiary institution is the Ministry of Agriculture, Forestry and Water Economy (MAFWE) and the final beneficiaries are Department for Agricultural / Unit for Fisheries and Aquaculture, Food and Veterinary Agency, State Agriculture Inspectorate, Agency for Financial Support in the Agriculture and Rural Development.
