(hereinafter "**Invitalia**"), – Via Calabria, 46, Rome – NUTS Code: ITI43 – 00187, Fax +39 06 42160457 (only in the event of unavailability of the e-procurement system and certified email), has launched an open tender procedure pursuant to the Italian Ministry of Foreign Affairs Decree no. 192 of 2 November 2017 "Regulation containing the general guidelines governing the procedures for selecting contractors and the execution of the contract to be carried out abroad, under the terms of Article 1, paragraph 7 of Italian Legislative Decree no. 50 of 18 April 2016" as Central Purchasing Office on behalf of the Commissioner General of the Section for the Italian participation in EXPO 2025 Osaka (hereinafter "**Commissioner**"), for the award of the contract for the "**PROJECT MANAGER SERVICE AND RELATED SERVICES IN FAVOUR OF THE COMMISSIONER GENERAL OF SECTION FOR ITALIAN PARTICIPATION IN EXPO 2025 OSAKA**" to be awarded with the criterion of the most economically advantageous offer, managed by means of a computer system. TENDER IDENTIFICATION CODE (CIG): [98111977E3], UNIQUE PROJECT CODE (CUP): [J34J21000090001] – The estimated total value of the contract, including optional services, is **€ 920,000.00 (nine hundred and twenty thousand/00 euros)**, plus VAT and legal fees if due, net of indirect taxes.

Deadline for receipt of tenders: at 10:00 am on 12 June 2023. The Call for Tenders was published on the Commissioner's institutional website [<https://www.italyexpo2025osaka.it/bandi-e-gare>], on the website of the Italian Ministry of Foreign Affairs and International Cooperation [https://www.esteri.it/it/trasparenza_comunicazioni_legali/bandi-gara-contratti/bandi-di-gara-e-contratti-rete-diplomatico-consolare-e-istituti-di-cultura/], on Invitalia's website [<https://ingate.invitalia.it>], as well as on the e-procurement website of the Organiser of Expo 2025 Osaka, accessible upon accreditation at [<https://www.expo2025.or.jp/en/association/maintenance/category/contract-information/>] and forwarded, on a voluntary basis, to the Publications Office of the European Union electronically for publication in the Official Journal of the European Union. The criterion for awarding the contract is that of the economically most advantageous tender. The other information relating to the CPV Code, the conditions of participation, the terms and duration of the contract, the options and variants, the non-division into lots are contained in the tender regulations to which reference is made. The Administrative Court of Rome shall be the entity responsible for any recourse proceedings regarding these procedures. Under the terms of Article 120, paragraph 5 of Italian Legislative Decree No. 104 of 2 July 2010, the deadline for presenting recourse against the Notice and these Rules for reasons that preclude



participation in this procedure is 30 (thirty) days with effect from the publication of the Notice on the Client's Profile.

Any dispute that may arise in relation and with reference to the execution of the tender contract, including those of a non-contractual nature, related to or associated with the latter, shall be resolved by arbitration based on the Milan Arbitration Board Arbitration Rules, as per Annex 8 to these Rules. The Board shall comprise three arbitrators, appointed in accordance with this Regulation, and pursuant to the last section of paragraph 3 of Article 2 of the New York Convention of 10 June 1958, namely the "Convention on the Recognition and Enforcement of Foreign Arbitral Awards". The Arbitration Board shall decide according to Italian Law. Arbitration will be conducted in Rome. Arbitration will be conducted in English.
