Foreword

The global crises we have witnessed in recent years, from the pandemic to the Russian Federation's aggression against Ukraine, through to Hamas's brutal terrorist attack against Israel and its repercussions onto Gaza and the entire Middle East, unequivocally reveal the features of the new international context in which Italy is called upon to operate. The intensification of international competition to the detriment of cooperative logics, the desire of revisionist powers to ride the rising polarisation in view of rediscussing the multilateral order in force since 1945, and the clash of values between democracies and autocracies are just some of the international system's political evolutions that can be seen today. From an economic standpoint, the globalisation process, in which excessive hopes had been probably pinned and which has instead proved to be a harbinger of potential vulnerabilities, appears to have been undermined in its assumptions and functioning. The priority of ecological transition is now complemented by the need to ensure greater security in the supply of energy sources and strategic raw materials. Finally, the complexity of the international scenario is compounded by the prominence and protagonism of non-State actors – such as large industrial and technological groups, conglomerates or aggregations of transnational interests - and by multiple disinformation activities, which make distinguishing truth from falsehoods increasingly complex.

The year 2023 was emblematic of said changes. It was marked by the continuation of the conflict on European soil and the implications of the ill-advised Russian move for Italian foreign policy and the action of the Italian Ministry of Foreign Affairs. Suffice it to mention the enlargement of NATO to Finland and, in perspective, to Sweden; the centrality of energy security and the efforts made by Italy to diversify from Russian supplies, as well as the G7 initiatives in the process of reuniting the West.

While taking a snapshot of the structure, resources, activities and services of the "universe of the Italian Ministry of Foreign Affairs" - a complex machine based on 308 foreign offices, in addition to the Headquarters, in which approximately 7,000 permanent, non-permanent and on-contract staff members operate – the Statistical Yearbook of the Italian Ministry of Foreign Affairs and International Cooperation, containing explanatory tables referring to 2022, shows an institution that has returned to full operation after the COVID phase, ready to keep the rudder straight in the face of the changes that govern international relations, but also to adapt its action in line with the needs of citizens, families and businesses on the international stage.

With specific reference to development cooperation and humanitarian aid, efforts were largely focused on the geographical area indicated by the Italian government as a priority in Italian foreign policy, i.e. Africa. Compared to 2021, there was indeed a significant increase in disbursements on the bilateral channel in favour of African countries, including through the Italian Agency for Development Cooperation (AICS), which reached a total of just over one billion euro. Among the various areas of intervention, MAECI focused on humanitarian aid, social services and rural development.

Faced with an ever-increasing "demand for Italy" from abroad – also demonstrated by a strong increase in tourist visas (+376%) – the Italian Ministry of Foreign Affairs continued to promote the Italian economic system through the organisation of promotional events in art, culture, cuisine, and design, as part of the "VivereALL'Italiana" initiative, with numbers up on the previous year (9,112 compared to 5,608 in 2021, +62%), and the renewed support for the internationalisation of enterprises also through collaboration with SIMEST, for an increasingly effective "Growth Diplomacy".

The results of the first year of activity of the Directorate General for Public and Cultural Diplomacy are positive. According to the 2023 Global Soft Power Index, Italy ranks ninth in the world, one step above the 2021 level. Culture, education, and civil society relations remain some of Italy's most effective soft power tools, and MAECI is committed to strengthening the relevant promotional actions. In 2022, Italy's Permanent Delegation to UNESCO, as well as the

Italian Cultural Institutes in Almaty (Kazakhstan) and Miami (USA), were established; the number of scholarships granted to Italians and to foreign nationals grew by 14%, and the involvement of the international public in the main Italian public diplomacy events increased (the number of video views of the Rome MED Dialogues rose from 4.1 to 4.5 million).

At a time when the safety and security of Italian nationals is exposed to new threats, assistance to Italian communities abroad has been strengthened through 54,000 consular protection operations, the services provided through the Fast-It portal (500,000 services, +4% compared to the previous year), the elevation in rank of offices in locations highly frequented by Italian citizens (the Consular Agency in Arona, Spain, established in 2021, is now a Vice Consulate) and the tests concerning the issuing of the Electronic Identity Card in some non-EU locations of the diplomatic-consular network. The number of Italian nationals enrolled in the AIRE registers increased by more than 200,000 (+ 3.1%).

With a view to ensuring greater effectiveness in its action in support of the country, the Italian Ministry of Foreign Affairs is committed to optimising existing resources, but also to adjusting staffing levels that are no longer sufficient for the purpose. After many years of a freeze on selection procedures, new public competitions were finally held in 2022 to strengthen administrative staff, also within the framework of the National Recovery and Resilience Plan – a compass available to our country for a full post-pandemic recovery.

I am convinced that the pages of this Yearbook – which meets expectations that are renewed every year – will enable readers to fully understand the spirit of service that characterizes those who proudly serve their country every day, both in Rome and in the foreign Offices.



The diplomatic-consular network comprises 129 Embassies, 9 Permanent Representations (has been established the Permanent Delegation of Italy to UNESCO in Paris), 1 Special Diplomatic Delegation, 83 Consular Offices and 86 Italian Cultural Institutes (there are two new Institutes in Miami and Almaty) for a total of 308 offices. The geographical distribution is shown below:




FIGURE 1.1 - NETWORK ABROAD BY TYPE AND GEOGRAPHICAL AREA




FIGURE 1.2 - PERMANENT STAFF

In terms of gender, as at 31st December 2022, 46% of the total permanent staff is female and 54% male.




FIGURE 1.3 – STAFF SERVING ABROAD BY GEOGRAPHICAL AREA

On the whole, the staff serving abroad (approximately 5 000 staff - Figure 1.3) is distributed as follows: 28% in European Union, 22% in the Americas, 16% in non-EU Countries and in Asia, 11% in the Mediterranean area and Middle East and 8% in Sub-Saharan Africa.

FINANCIAL RESOURCES

This section presents the data on financial resources assigned to the Ministry of Foreign Affairs and International Cooperation based on the Budget Law. The Budget of MAECI is broken down into three series of data (Table 1.16), with the aim of highlighting the amount and allocation of financial resources.

The MAECI Budget: The 2023 budget (3 285 million euros) includes the total value of funds managed globally for implementing Italy's foreign policy and international cooperation activities. This amount therefore includes the allocation that has been transferred to the Italian Agency for Development Cooperation (AICS) and to the European Development Fund (EDF) as well as the expenses earmarked to pursue the foreign policy priorities (through financial transfers to bodies that do not belong to MAECI, such as for instance the compulsory contributions paid to international bodies and institutions) and to incur operating costs.

The appropriations recorded in the MAECI budget include the financial resources allocated for the promotion of international trade and the internationalization of the production system.

The final balance of MAECI: for fiscal year 2023 the resources used for the functioning of the Administration amount to 1 133 million euro. This value represents 0.10% of the State Budget.




FIGURE 1.4 - MAECI BUDGET




FIGURE 1.5 - MAECI BUDGET: PERCENTAGE OF THE NATIONAL BUDGET

As at 31.12.2022 the Honorary Consulates open to the public, headed by a Consul with operational powers, were 348.

Unlike tenured officers, honorary officers are not hired by the Administration. They perform the consular functions defined in ad hoc ministerial decrees and receive only reimbursements and contributions to cover office and representation expenses, while they themselves incur the costs related to the execution of the assignment.




FIGURE 2.1. – VISITS ABROAD AND INTERNATIONAL MEETINGS ATTENDED




FIGURE 2.2 – ITALIAN LANGUAGE COURSES AND STUDENTS ENROLLED

Chapter 2

Incentives for translation, dubbing and subtitling

In 2022 a total of 313 incentives were assigned for the translation and dubbing/subtitling of Italian films, in the form of prizes and contributions.

VivereALL'Italiana

The network organised 9 112 events in different areas of activity such as the cinema, entertainment, contemporary art, haute cuisine and design.

Week of the Italian Language in the World

As part of the initiatives organised for the Week of the Italian Language in the World, special notice should be taken of of 227 events in the language field.

Scholarship granted to foreign students

The scholarship assigned by the Italian Government for academic year 2022/2023 were 5 532.

Scientific and technological cooperation

65 projects of "great relevance" were accepted for funding, accounting for 93% of the initiatives included in the executive programmes. In 2022, 81 researchers carried out such exchanges, to and from Italy, as part of mobility projects.

ECONOMIC DIPLOMACY

The diplomatic-consular network, together with the Chambers of Commerce and ICE, the Agency for the Promotion and Internationalisation of Italian Companies - continued its commitment to supporting Italian companies operating in the world, by also providing information on tenders and large orders: in 2022, information about approximately 5 000 tenders and preliminary information about 500 tenders and large orders were provided (table 2.19).

ITALIANS ABROAD

This section includes data concerning the presence of Italian citizens abroad, consular services and Italian detainees.

Consular registers and services

The Italian citizens abroad enrolled in consular registries are 6 706 594 (+3.1% on previous year).




FIGURE 2.3 - ITALIAN CITIZENS ENROLLED IN CONSULAR REGISTRIES




FIGURE 2.4 - MAIN CONSULAR SERVICES

Italian prisoners abroad

In 2022 the number of Italians detained abroad is 1 924. However, note should be taken of the persisting difficulty in surveying the detainees because the privacy provisions in force in certain countries are very stringent and make it difficult to collect information on the phase of the judicial proceeding or the level of jurisdiction.

ENTRY VISAS

808 647 visas issued out of 902 215 applications processed in 2022. The Russian Federation ranks first in terms of the number of visas issued, followed by Türkiye and India.




FIGURE 2.5 - ENTRY VISAS: TOP 20 COUNTRIES BY NUMBER OF ISSUED VISAS




FIGURE 2.6 - TOP 10 COUNTRIES IN RANKING ORDER IN TERMS OF DISBURSEMENTS




FIGURE 2.7 - WEBSITES UNIQUE PAGE VIEWS

CHAPTER 3

COMPARISON WITH OTHER COUNTRIES

The third chapter of the Statistical Yearbook illustrates the main elements common to the Foreign Ministries of a number of European countries (France, Germany, the Netherlands, Poland, the United Kingdom, Spain and Türkiye).

The comparative data concerns the organisational structure, the staffing levels (broken down by permanent and non-permanent staff), the budget shares.

The reference sources for the national budget and GDP data are EUROSTAT and the International Monetary Fund, while the data and statistics regarding the human and financial resources of the Foreign Ministries are collected by the local administrations through the diplomatic offices.

The result is interesting above all for the size of values in absolute terms, but it should be noted that in the comparative analysis and interpretation of data, the complexity of comparing different institutions must always be borne in mind, not only in terms of the form of State and Government, but also in terms of methods and procedures applied to national accounting and human resources management.
