## Decision of the Director-General for Resource Management of the European External Action Service

### **adjusting the amount of the allowances provided for in Article 16 of the Decision HR DEC(2014) 01 of the High Representative of the Union for Foreign Affairs and Security Policy establishing the rules applicable to National Experts seconded to the European External Action Service**

THE DIRECTOR-GENERAL FOR RESOURCE MANAGEMENT OF THE EUROPEAN  
EXTERNAL ACTION SERVICE,

Having regard to the Decision HR DEC(2014) 01 of the High Representative of the Union for Foreign Affairs and Security Policy of 4 February 2014 establishing the rules applicable to national experts seconded to the European External Action Service (hereinafter, the “Decision HR DEC(2014) 01”), as amended by Decision HR DEC(2014) 11 and in particular Article 16(5) thereof,

Whereas:

- (1) Article 16(5) of the Decision HR DEC(2014) 01 provides that the daily and monthly allowances of national experts seconded to the European External Action Service (hereinafter, the “EEAS SNEs”) shall be adjusted each year without retroactive effect on the basis of the adaptation of the basic salaries of EU officials in Brussels and Luxembourg.
- (2) In accordance with Article 65(2) of the Staff Regulations of Officials of the European Union and Article 4(1) of its Annex XI, the European Commission has published in the Official Journal of the European Union, on 11 December 2024, the 2024 annual update of the remuneration and pensions of the officials and other servants of the European Union and the correction coefficients applied thereto<sup>1</sup>. This update provides for an increase of 4.1% in the remuneration and pensions of the abovementioned categories of members of staff.
- (3) It is therefore appropriate to adjust accordingly, and without retroactive effect, the daily and monthly allowances of the EEAS SNEs,

HAS DECIDED AS FOLLOWS:

#### *Article 1*

The Decision HR DEC(2014) 01, of 4 February 2014, is hereby amended as follows:

1. In Article 16(1) of HR DEC(2014) 01, as lately amended by ADMIN(2024) 18 of 03 July 2024, the amounts “EUR 41.61” and “EUR 166.48” are replaced by the amounts “EUR 43.32” and “EUR 173.30” respectively;
2. In Article 16(2), the table is replaced by the following:
