Foreword

The year 2025 has shown again a trend towards global uncertainty, which is affecting the dynamics of relations between States and other international players. New equilibria are challenging the international system, increasing its instability and fuelling tensions that extend to trade and value chains. Eighty years after the establishment of the United Nations, there is an urgent need to reform the Security Council - a body in which cross-vetoes prevent the full achievement of goals - along the lines of greater inclusiveness and democracy.

Against this backdrop, Italian diplomacy is active on all fronts to contribute to global stabilisation, leveraging a solid system of Euro-Atlantic alliances and its traditional ability for dialogue. At the same time, it is also committed to the country's growth, a priority that the Deputy Prime Minister and Minister of Foreign Affairs and International Cooperation, Antonio Tajani, has placed at the heart of the reform that will come into force on 1 January 2026 to equip the Foreign Ministry to rise to future challenges.

A quick glance at our neighbours confirms a picture of difficulty and tension. In the Middle East, the ceasefire between Israel and Hamas has rekindled hopes for the potential of negotiations and multilateralism, but many questions remain unanswered, especially regarding the future of the Gaza Strip, to which Italy has shown strong commitment, primarily through the "Food for Gaza" initiative. While Russia's illegitimate war on Ukraine continues, Italy has shown its support for the Ukrainian people, also in terms of reconstruction, as demonstrated by the significant international discussion held at the Recovery Conference hosted in Rome last July. In this context marked by rivalry, the European Union is committed, with Italy's support, to accelerating the path towards taking greater responsibility in the areas of security, the revival of industrial competitiveness, enlargement and the establishment of new trade partnerships.

Thanks to the Mattei Plan, Italy has an innovative long-term strategy for the implementation of a new paradigm of cooperation "on equal terms" with Africa, which enhances the experience of Italian development cooperation within the framework of the country's systemic action.

Faced with the risks inherent in the spreading of competitive logics, protectionist measures, transactional patterns and negotiation dynamics, the flexibility, understanding and connections of Italian diplomacy appear to be fundamental to pursuing both the maintenance of effective multilateral frameworks and the diversification of relations that ensures prosperity and affects crucial regions, ranging from Latin America to the Indo-Pacific. This goal is also supported by Italy's ability to persuade and attract, leveraging its unique cultural heritage and the growing interest in the Italian language, as well as a range of areas of excellence, ranging from scientific research to space and sports.

The 2025 Statistical Yearbook aims to provide policy makers with, citizens and companies a snapshot of diplomacy tools and activities as of December 31, 2024. The Foreign Ministry is divided into its Headquarters and 313 Offices abroad (including the two new Italian Cultural Institutes established in Amman and Bangkok), which are called upon to provide citizens and companies with the same number of operational centres for services and assistance, employing over 7,000 permanent, temporary and contract staff. In this regard, it is worth noting that approximately 1,300 new administrative staff have been hired in the current year, thus reaffirming the commitment to gradually strengthening the workforce, with a parallel focus on training.

The main new developments in the foreign network reflect the priority guidelines for diplomatic action set out by the Deputy Prime Minister and Foreign Minister, Antonio Tajani.

Firstly, support for the growth and internationalisation of companies. In 2024, the Foreign Ministry played a proactive role in promoting a 55% increase in subsidised finance operations to support the international development of companies, as well as a 43% increase in financing adopted and allocated from the Venture Capital Fund for the purchase of shareholdings in companies established abroad. There was also a positive sign of interest from companies in the information services offered by the Foreign Ministry to support internationalisation (a 14% increase in the number of views of the "Export.gov.it" platform and an 11% increase in views of the "Informercestieri.it" platform).

Secondly, growing attention is paid to Africa. Last year Africa received a total of over €700 million in development cooperation, with a particular focus on sustainable economic growth. This effort is part of a trend of overall increase in Italy's Official Development Assistance (ODA) (€6.3 billion in 2024, of which over €1.1 billion was provided by the Foreign Ministry through bilateral and multilateral channels), bucking the trend of other international donors. It is also worth noting that the 57% increase in scholarships offered by the Italian government has mainly benefitted African students, in line with the Mattei Plan and the central role given to education in that plan.

Finally, the focus on consular affairs is confirmed - also considering the upward trend in the number of Italians registered with AIRE (over 7,000,000) - both in the provision of services (a 22% increase in electronic identity cards issued) and in the effort to simplify, streamline and digitise them (a 31% increase in registry services via the Fast-IT platform). The number of entry visas to Italy issued by our network is also growing (+16%, mainly for tourism, but also for business, employment and study).

The Foreign Ministry therefore reaffirms its determination to strengthen the diplomatic tools at the service of Italian citizens. Data can be examined in greater detail by analysing the various tables in this Yearbook.

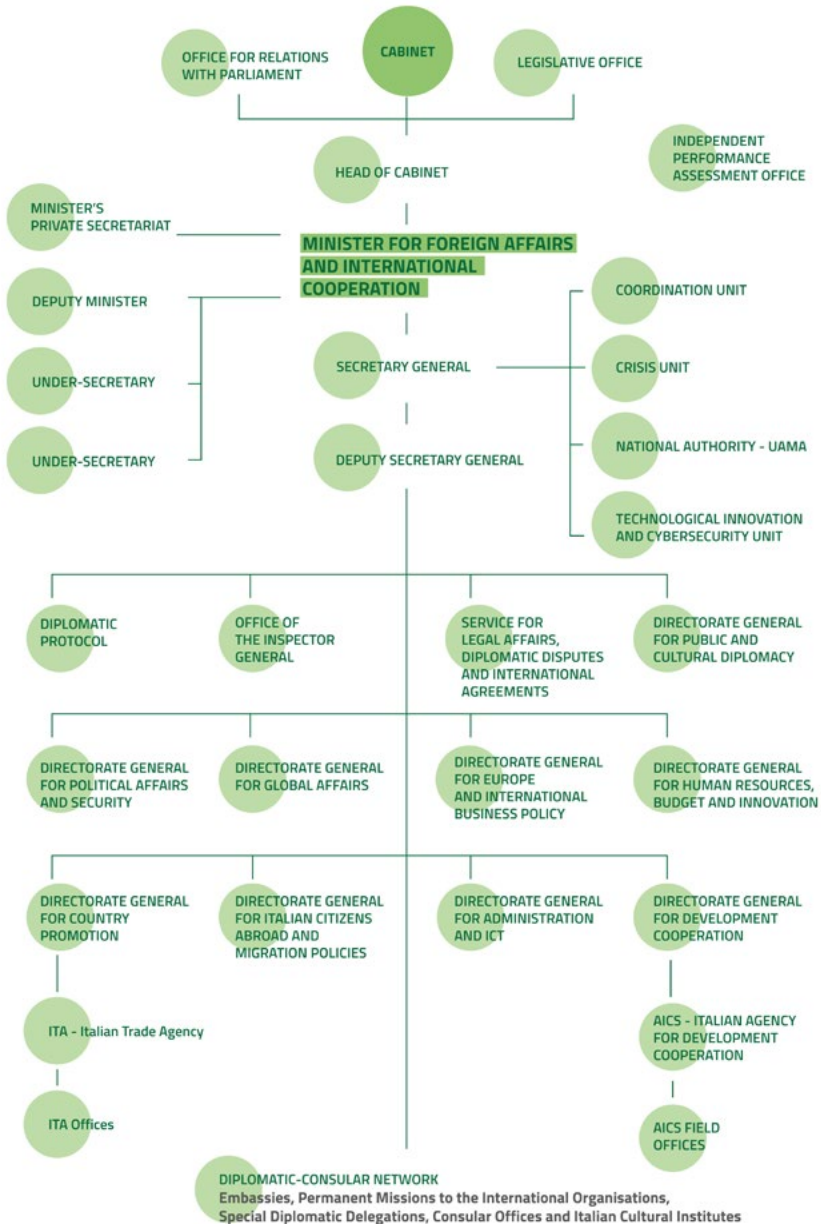

ORGANISATION AND RESOURCES

The organisational structure of the Ministry of Foreign Affairs and International Cooperation as at 31 December 2025 is shown in the following chart:



The diplomatic-consular network includes 130 Embassies, 9 Permanent Representations, 1 Special Diplomatic Delegation, 85 Consular Offices and 88 Italian Cultural Institutes (with new Institutes in Amman and Bangkok) for a total of 313 offices. The geographical distribution is illustrated below:

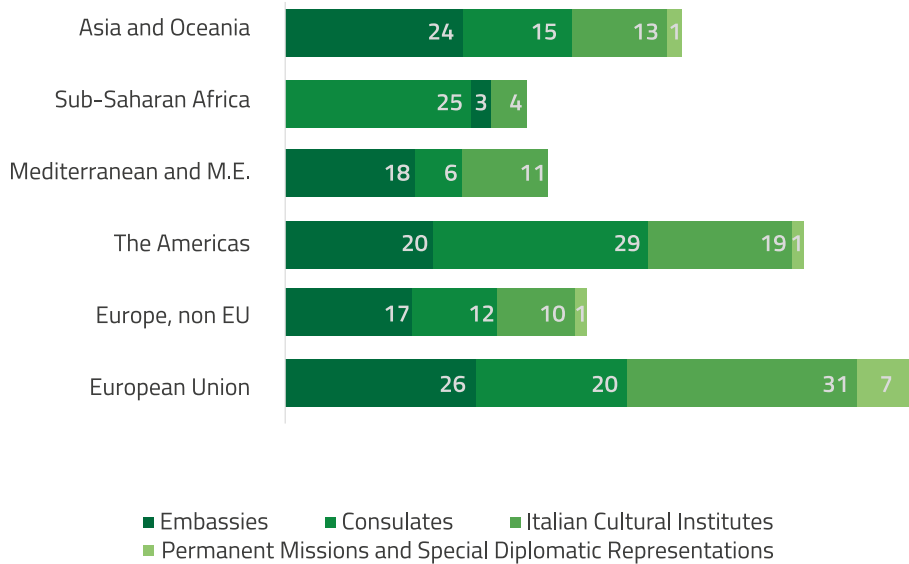


Figure 1.1 – Network abroad by type and geographical area

In 2024 the Ministry of Foreign Affairs and International Cooperation (MAECI) had 3 971 permanent staff members.

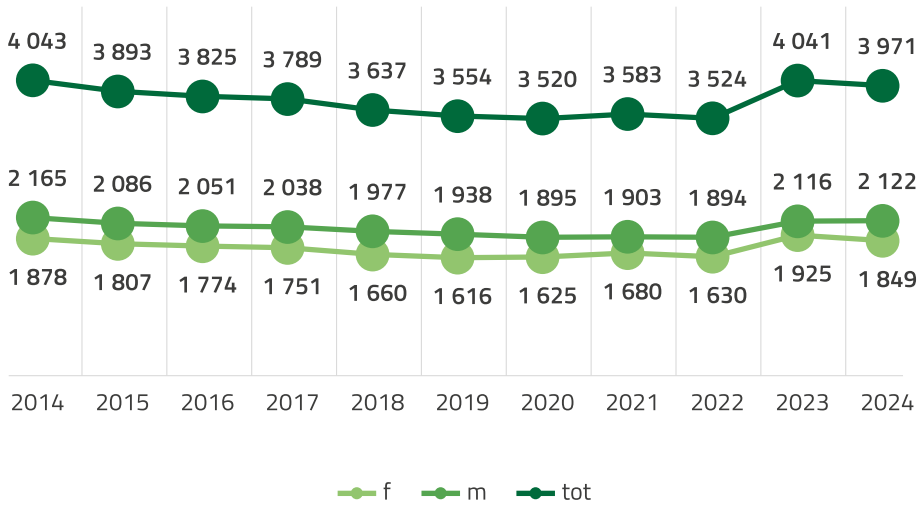


Figure 1.2 – Permanent staff by gender

In terms of gender, as at 31 December 2024, 47% of the total permanent staff is female and 53% male.

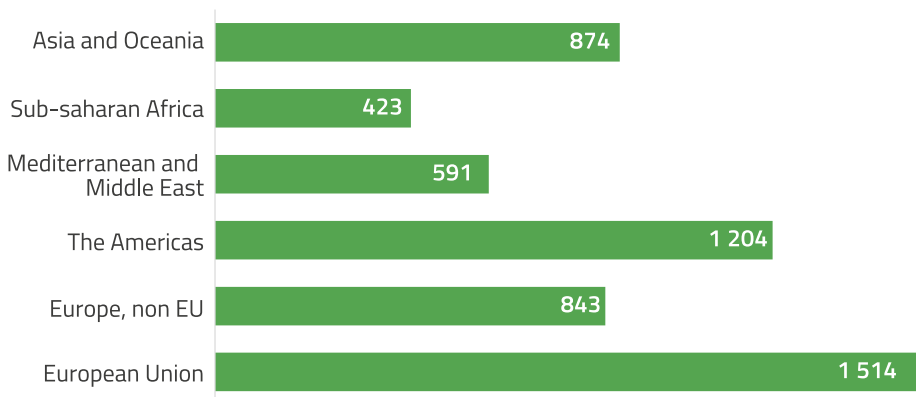


Figure 1.3 – Staff serving abroad by geographical area

Overall, the distribution of staff serving abroad is illustrated in Figure 1.3 as follows:

The Budget of MAECI is broken down into three series of data (Table 1.16), with the aim of highlighting the amount and allocation of financial resources.

The MAECI Budget: The 2025 budget (3 381 million euros) includes the total value of funds managed globally for implementing Italy’s foreign policy and international cooperation activities. This amount therefore includes the allocation that has been transferred to the Italian Agency for Development Cooperation (AICS) and to the European Development Fund (EDF) as well as the expenses earmarked to pursue the foreign policy priorities (through financial transfers to bodies that do not belong to MAECI, such as for instance the compulsory contributions paid to international bodies and institutions) and to incur operating costs. The appropriations recorded in the MAECI budget include the financial resources allocated for the promotion of international trade and the internationalisation of the production system.

The final balance of MAECI: for fiscal year 2025 the resources used for the functioning of the Administration amount to 1 198 million euro. This value represents 0.10% of the State Budget.

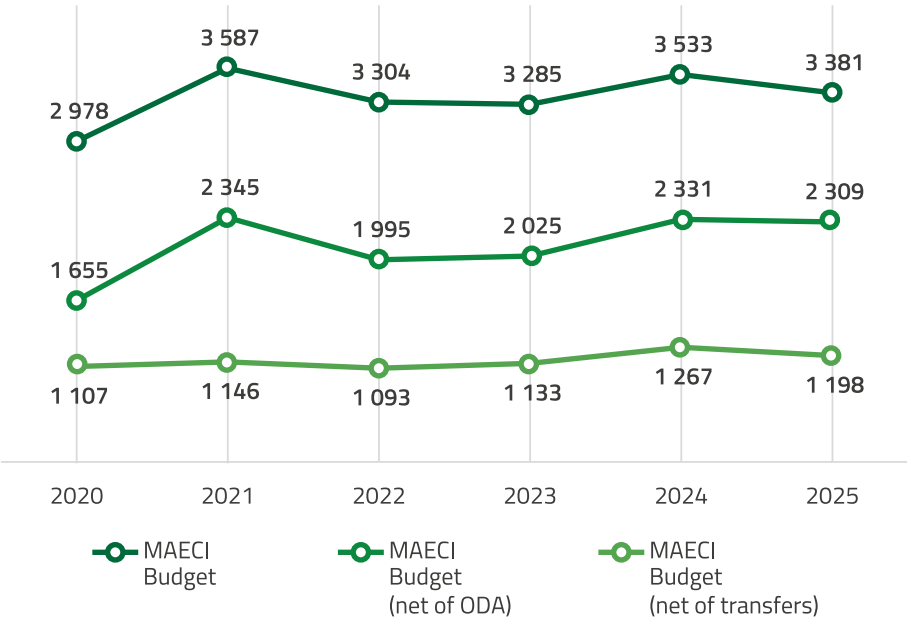


Figure 1.4 – MAECI budget (amounts in million euros)

As at 31.12.2024 the Honorary Consulates open to the public, headed by a Consul with operational powers, were 337.

Unlike tenured officers, honorary officers are not hired by the Administration. They perform the consular functions defined in ad hoc ministerial decrees and receive only reimbursements and contributions to cover office and representation expenses, while they themselves incur the costs related to the execution of the assignment.

INTERNATIONAL AFFAIRS

Agreements, international legal issues and judicial cooperation

Data on bilateral and multilateral agreements signed by Italy and those that entered into force as well as numerical information about international legal disputes and judicial cooperation are illustrated in tables from 2.5 to 2.9.

Foreign Diplomatic Representations

Italian language courses held by the Italian Cultural Institutes

Over 35,000 students were enrolled in language courses organised by the Italian Cultural Institutes.

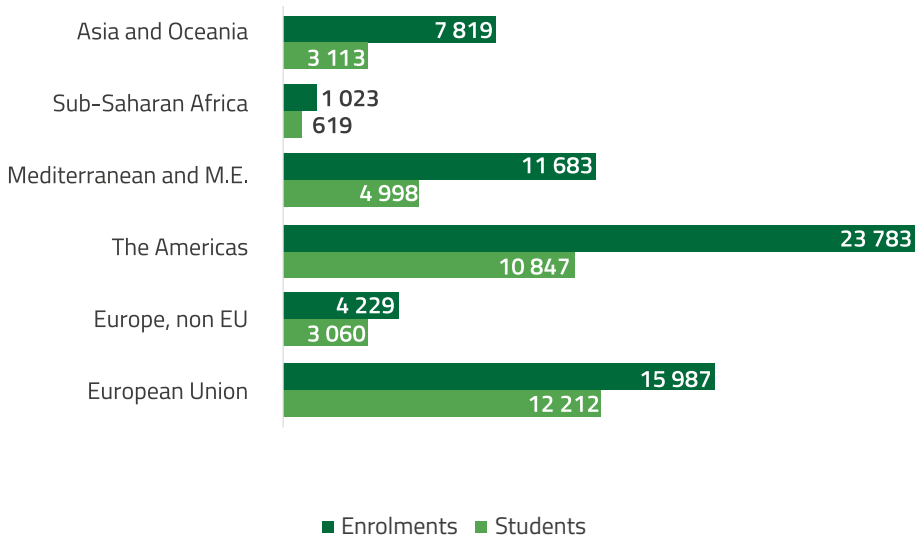


Figure 2.1 – Italian language courses organised by the Italian Cultural Institutes

Incentives for translation, dubbing and subtitling

In 2024 a total of 455 incentives were assigned for the translation and dubbing/subtitling of Italian films, in the form of prizes and contributions (+12%).

Integrated cultural promotion

The network organised 11,597 events in different areas of activity such as the cinema, entertainment, contemporary art, haute cuisine and design.

Week of the Italian Language in the World

As part of the initiatives organised for the Week of the Italian language in the World, special notice should be taken of 421 events in the language field.

Scholarship granted to foreign students

For the 2024/2025 academic year, an increase has been recorded in the number of scholarships awarded to students from Sub-Saharan Africa and Mediterranean area and the Middle East. More than 11,500 monthly scholarships were assigned by the Italian Government marking a 57% increase compared to the previous academic year.

Scientific and technological cooperation

Eighty-nine projects of "great relevance" were approved for funding, representing 96% of the initiatives included in the executive programs.

ECONOMIC

DIPLOMACY

The diplomatic-consular network, along with the Chambers of Commerce and ICE, the Agency for the Promotion and Internationalisation of Italian Companies, continued its commitment to supporting Italian companies operating worldwide. In 2024, they also provided information on tenders and large orders, sharing details about 5,374 tenders and preliminary information about 449 large orders.

This section includes data concerning the presence of Italian citizens abroad, consular services and Italian detainees.

ITALIANS ABROAD

Consular registers and services

The number of Italians enrolled in consular registers has exceeded 7 million, with an increase of +2% compared to 2023. Argentina remains the Country with the largest Italian community, with almost 1.2 million registrants, followed by Germany, Brazil, and Switzerland.

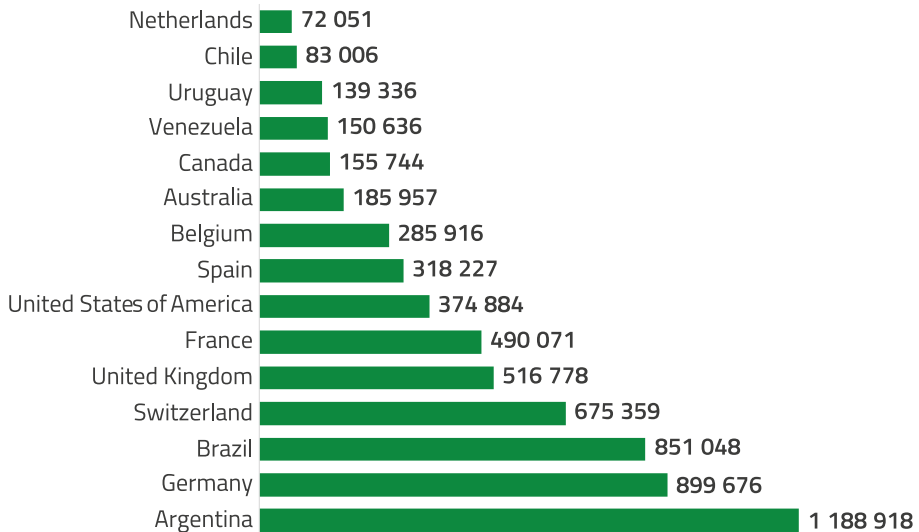


Figure 2.2 - Italian citizens enrolled in consular registers

Accordingly, there is an increase in consular services especially in the issuance of Electronic Identity Cards (+22%).

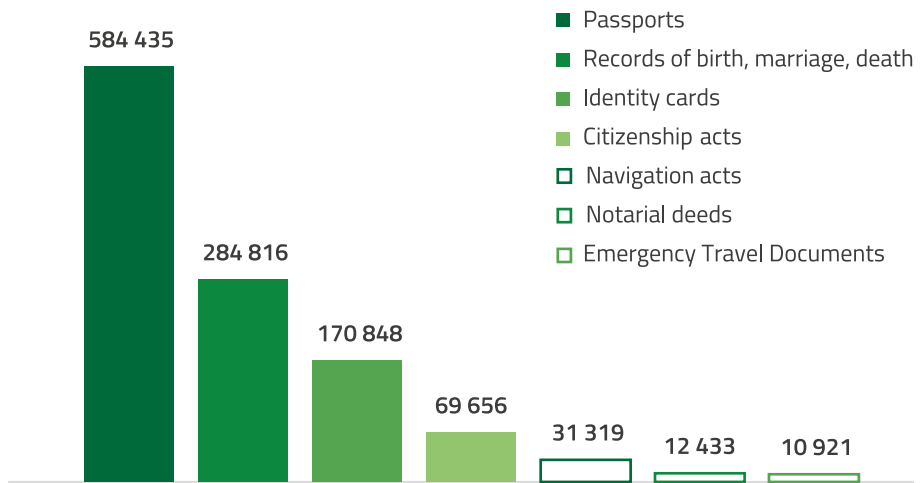


Figure 2.3 - Main consular services

Italian prisoners abroad

In 2024, the number of Italians detained abroad was 2,145. However, it is important to note the persistent challenges in surveying detainees due to strict privacy provisions in certain countries, which complicate the collection of information on the judicial proceeding's phase or jurisdictional level.

VISAS

In 2024, 1.3 million visas were issued. The People's Republic of China ranks first in the number of visas issued, followed by the Russian Federation and Türkiye.

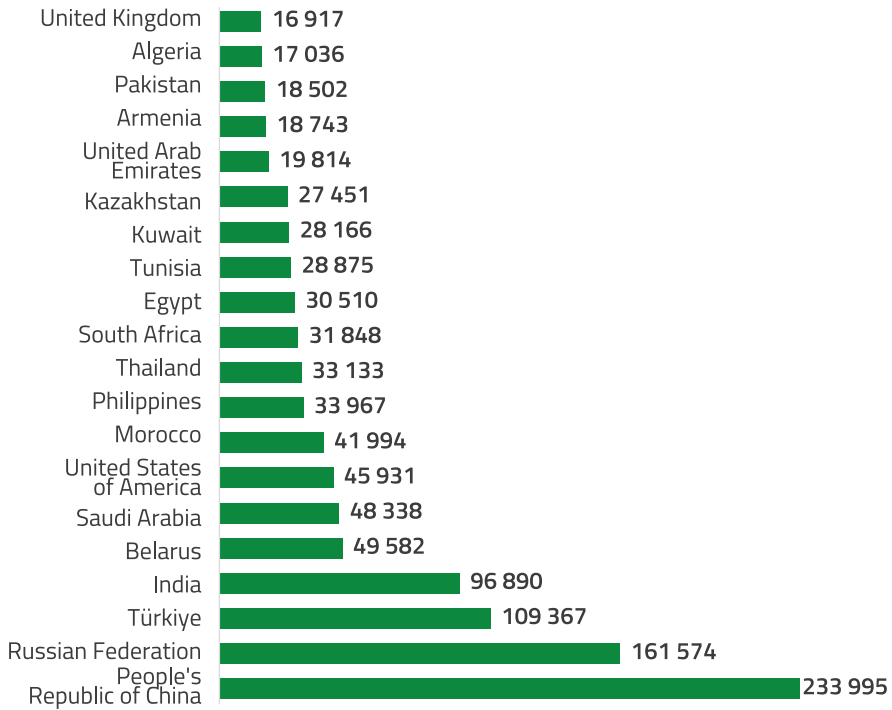


Figure 2.4 - Entry visas: top 20 countries by number of issued visas

DEVELOPMENT COOPERATION

The resources allocated to the financing of development cooperation by the DGCS/AICS and the other MAECI DGs for the bilateral channel amount to EUR 683 million, those for the multilateral channel amount to EUR 433 million.

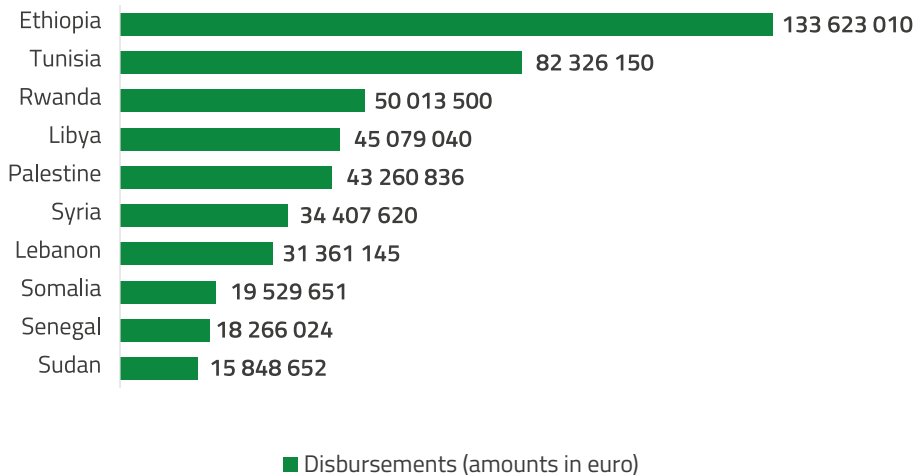


Figure 2.5 - Top 10 Countries in ranking order in terms of disbursements

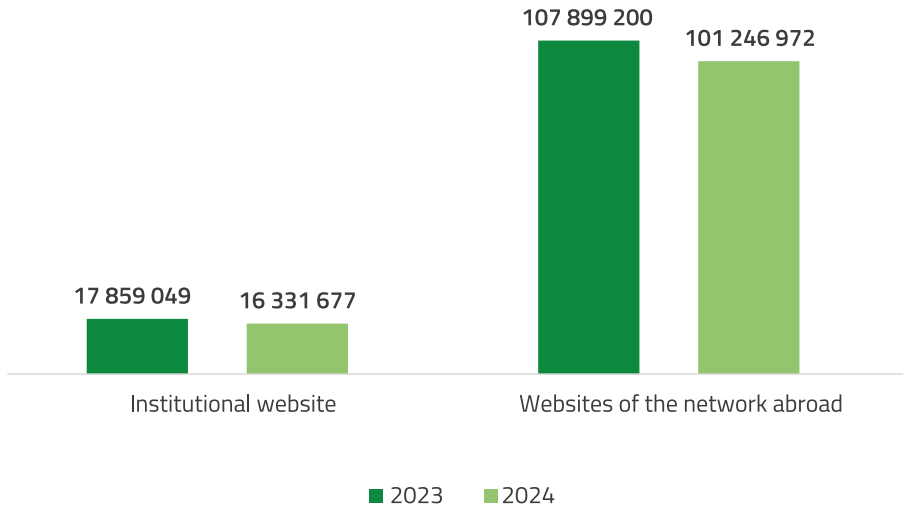


Figure 2.6 - Websites unique page views

CHAPTER 3

COMPARISON WITH OTHER COUNTRIES

COMPARISON WITH OTHER COUNTRIES

The third chapter of the Statistical Yearbook highlights the key elements common to the Foreign Ministries of several European countries including France, Germany, the Netherlands, Poland, the United Kingdom, Spain and Türkiye. The comparative data addresses the organizational structure, staffing levels (distinguished between permanent and non-permanent staff), and budget allocations (both State and Ministry of Foreign Affairs budget).

The reference sources for national budget and GDP data are EUROSTAT and the International Monetary Fund. Data and statistics regarding the human and financial resources of the Foreign Ministries are directly obtained from local administrations through diplomatic offices. The results are particularly interesting for their absolute values. However, it is essential to consider the complexity of comparing different institutions, not only in terms of the form of State and Government, but also in the methods and procedures applied to national accounting and human resources management.
