



**ITALY – VIETNAM**  
**SCIENCE AND TECHNOLOGY COOPERATION**  
**CALL FOR JOINT PROJECT PROPOSALS FOR THE YEARS 2027-2029**  
**CLOSING DATE: 10 August 2026**  
**In Italy: at 14:00 hr C.E.S.T.**  
**In Vietnam: at 17:00 hr GMT + 7**

**BACKGROUND**

*Within the framework of the Scientific and Technological Cooperation Agreement between the Government of the Republic of Italy and the Government of the Socialist Republic of Vietnam, signed in Hanoi on January 5th, 1992 and entered into force on May 10<sup>th</sup> 1998, the Directorate General for Growth and Export Promotion– Office XI of the Italian Ministry of Foreign Affairs and International Cooperation (MAECI) and the Department of International Cooperation of the Ministry of Science and Technology of Vietnam (MST), hereinafter referred to as the “Parties”, are opening a call for proposals for the renewal of the Executive Programme on Scientific and Technological Cooperation for the years 2027-2029.*

**1. DESCRIPTION**

**1.1 FUNDING SCHEMES**

With regard to the present call, the available funding scheme is **“Joint Research Projects”**.

The aim of this funding scheme is to encourage bilateral collaboration between research teams of the two countries. The expenses for research activities are funded by both Parties: MAECI will provide funds for the Italian team (or, alternatively the Ministry for Universities and Research – MUR), MST will provide funds for the Vietnamese team.

**1.2 ELIGIBILITY REQUIREMENTS**

Project proposals:

- must have the same duration of the Executive Programme (E.P.): **3 years**.
- Each Principal Investigator (PI) can submit **only one proposal**
- Must be coherent with respect to the call requirements, both for scientific and financial aspects

**Country-specific rules: Italian Party**

- The call is open to public or private (no-profit) research institutions
- The PI must have Italian or any other EU nationality, legal residence in Italy, and must be affiliated with a public or private (no-profit) Italian research institution with a permanent

position, or with a temporary position covering at least the first year of activity of the proposed project (the termination date of the contract shall be declared in the CV).

- The total amount requested to MAECI or MUR must be approximately the same for each of the three years (i.e. approximately 33% per year). If a project is selected for financial contribution, the original budget proposal will be valid throughout the duration of the EP. Minor adjustments are permitted upon approval.

### **Country-specific rules: Vietnamese Party**

- The call is open to science and technology organizations, individuals engaged in science and technology activities, state agencies, and organizations and individuals with registration of scientific and technological activities as prescribed by Vietnamese law. Project proposals must comply with Vietnamese national funding policy.

### ***1.3 REASONS FOR EXCLUSION***

- lack of any one of the eligibility requirements listed above;
- incomplete application (including additional documents where applicable - see point 3 below);
- proposals submitted in different priority research areas in the two countries by the collaborating PIs;
- proposals submitted in only one of the two countries.

## **2. PRIORITY RESEARCH AREAS**

Project proposals must be submitted within one of the following research areas.

1. Advanced biomedical and pharmaceutical technologies, Healthcare;
2. Green transformation: Circular economy, clean energy, advanced environmental and waste treatment technologies, climate change adaptation, efficient resource use and ecosystem conservation;
3. ICT technologies: AI, high-performance computing (HPC), quantum technology, semiconductors and next-generation mobile networks (5G/6G).

**Proposals submitted in other research areas will not be considered for evaluation.**

## **3. SUBMISSION PROCEDURES**

Joint proposals must be separately submitted by the Italian and Vietnamese PIs to their respective Parties, following the country-specific submission procedures listed below. Unilateral applications are not accepted and will not be considered for evaluation.

### **Italian Party**

- Proposals shall be submitted exclusively online, by filling out the dedicated forms at the following link: <https://pgr.esteri.it/>

- **Proposals must be entirely written in Italian or English. Other languages will not be accepted.**

- For projects involving experiments with animals, the status of ethics approval by the competent Ethics Committee must be provided when submitting the proposal. A declaration of submission of the experimental protocol to the institutional OPBA (Organismo Preposto al Benessere degli Animali) within the project description is acceptable at the proposal submission stage. Please note that formal authorization by the competent Ministry of Health is mandatory to start the activities (D.Lgs 26\_04/03/2014 and Directive 2010/63 EU). Projects involving experiments with human beings must be performed in accordance with the Directive 536/2014/EC. The Italian Principal Investigator should include a self-declaration of adhesion to the above cited rules in the Methods section of the proposal.
- Applications for the Joint Research Projects funding scheme must be accompanied by an endorsement letter signed by the legal representative of the applying Institution or her/his delegate duly authorized by formal provision. The letter, which must be written in Italian or English using the template available for download at the same URL of the present call, should acknowledge the submission and provide official acceptance of all conditions listed in the call text, including the institutional co-funding listed in the provisional budget section of the proposal. Moreover, if the PI holds a temporary position, the endorsement letter must also certify that, should the contract be terminated before the end of the project, the Institution will replace the PI with another member of the research team, thus ensuring that research activities are carried out without any interruption. The endorsement letter must be uploaded to the webpage available at the link: <https://pgr.esteri.it/>.

### **Vietnamese Party**

- **Proposals must be entirely written in Vietnamese with title and summary also in English. Other languages will not be accepted.**
- The proposal should include the followings: Description of project objectives, main research contents, cooperation plan, human resources for carrying out project, work assignment between Italian and Vietnamese project partners, anticipated results, cost estimates, main regulations for commercialization of project results.
- PIs will be requested to submit full proposals including the following documents:
  - Detailed project description
  - Cooperation Agreement between Vietnamese project participating institutions
  - Cooperation Agreement between Vietnamese and Italian institutions (in English and Vietnamese translations)
- The minimum requirements for an Agreement should be as follow:
  - Project title
  - Name of participating institutions
  - Description of project objectives, main research contents, cooperation plan, human resources for carrying out project, work assignment between Italian and Vietnamese

project partners, anticipated results, cost estimates, main regulations for commercialization of project results.

- The full proposals should be submitted together with other administrative documents according to Vietnamese regulations.
- Projects must have duration of 3 years and written in Vietnamese (according to Annex 1 attached with the title and summary also in English).

## **4. EVALUATION OF PROPOSALS AND SELECTION AT NATIONAL AND BILATERAL LEVEL**

### **4.1 EVALUATION PROCESS**

Following the close of the call, all submitted proposals will undergo a formal eligibility check.

Eligible applications will then be reviewed based on their relevance to the strategic objectives and potential for scientific and technological cooperation between the parties.

Subsequently, the evaluation process of the proposals which have passed the previous two steps will be performed at the national level to identify a shortlist of the top-ranking proposals. Finally, at bilateral level, the two Parties will compare the results of the evaluation process and reach consensus on the final list of projects eligible for funding during the meeting of the Joint Commission which, as defined in Article 4 of the bilateral Agreement, includes representatives of both Parties. The selected projects will be included in the text of the Executive Programme, that will be signed by both Parties during the Joint Committee meeting and posted on their websites. The Executive Programme will also set out the bilateral priorities in the field of Science & Technology for the period 2027-9.

Proposals will be evaluated according to the following criteria:

- Scientific relevance;
- Competence and skill of the research teams;
- Methodology and documentation;
- Added value to the bilateral cooperation;
- Budget adequacy

- Significant advancement of the Technology Readiness Level (TRL), including possible future applications

In the event of a tie in score, priority shall be given to applicants who have not been part of research groups previously funded by MAECI.

#### **Vietnamese Party:**

The project evaluation must follow regulations set forth by the Circular Nr. 10/2019/TT-BKHCH dated 29 October 2019 regulating procedure for management of joint research projects with foreign partners. Eligible project proposals will be evaluated by scientific commissions established by the Ministry of Science and Technology.

The proposal needs to fully meet the criteria of the national science and technology tasks according to the current regulations of the Ministry of Science and Technology, as well as meet the conditions according to the Circular No. 10/2019/ TT-BKHCH dated October 29, 2019 of the Minister of Science and Technology in accordance with regulations on management of scientific and technological tasks according to the protocol. The Protocol mandate should be technologically disruptive.

The products of the project must reach the advanced level in the region and in the world. The products of the project need to fully meet the requirements of the national science and technology mission with products of type I, type II and type III:

- \* Type I products must be advanced products with clear technical specifications.
- \* Type II products prioritize advanced technological processes.
- \* Type III products include at least 01 articles published in journals in the list of ISI/Scopus, 2 articles in prestigious scientific journals in the country, and are scored by the peer-reviewed and interdisciplinary professor council issued by the Nafosted Fund.
- \* Type IV products: Trained at least 01 master's degree or contributed to doctoral training (in the direction of the graduation thesis to comply with the contents of the cooperation protocol).

## **4.2 OUTCOME OF THE EVALUATION**

#### **Italian Party**

**Only the PIs of the selected projects will be notified by e-mail of the outcomes of the selection process.**

#### **Vietnamese Party**

PIs of selected projects will be directly informed.

## **5. FUNDING PROCEDURES**

#### **Italian Party:**

Funding will be granted to the projects listed in the Executive Programme within the limits of the available annual resources of each Party.

The contribution granted by MAECI to “Joint Research Projects” is intended as co-funding support for the project, and therefore co-funding by the coordinating Italian Institution of approximately 50% of

the total costs of the project is mandatory. Co-funding can include salaries of the involved personnel and indirect costs.

The average cost of a project is approximately 60 K€/year, including co-funding by the applying institution.

The contribution granted by MAECI will be based on the 3-year original budget proposal.

- A **first** instalment, amounting to 100% of the first year MAECI co-funding (and approximately to 33% of the total MAECI co-funding) will be provided in advance, upon presentation of a letter certifying the beginning of project activities. Any unspent amount must be refunded to MAECI or can be used in the second year and deducted from the total contribution.
- The expenses for the **second year** (approximately amounting to 33% of the total MAECI co-funding) will be anticipated by the coordinating institution and reimbursed by MAECI during the third year, upon submission and positive evaluation of scientific reports and financial reporting documents.
- Similarly, the expenses for the **third year** (approximately amounting to 33% of the total MAECI co-funding) will be anticipated by the coordinating institution and reimbursed by MAECI after the end of the project, upon submission and positive evaluation of scientific reports and financial reporting documents.

**For the Vietnamese Party:**

The principal investigators of projects listed in the Executive Programme will be invited to submit the proposal with detailed financial requirements for financial evaluation according to Circular Nr. 10/2019/TT-BKHCN dated 29 October 2019 regulating procedure for management of joint research projects with foreign partners.

**6. INTELLECTUAL PROPERTY RIGHTS**

- Each Party will ensure appropriate protection of intellectual property rights (IPR) generated from cooperation pursuant to the Executive Programme signed by the two Parties consistent with their respective laws, rules and regulations.
- In case of research results obtained through joint activities, the grant of IPR will be sought by both Parties jointly and once granted these rights will be jointly owned by the Parties. However, the apportionment of such rights may be decided mutually by Parties through a separate written agreement.
- The Parties shall not assign any rights and obligations arising out of the IPR generated from inventions/activities carried out under the signed Executive Programme to any third party without the **prior** written consent of the other Party.

In case of research results obtained through joint activities under the Executive Programme will apply as co-applicants for the protection of IPR subject to exclusive rights of both the parties to commercialize the products deriving from research in their respective countries. Commercialization in any other country shall be done jointly through a separate agreement.

**7. THIRD PARTIES**

The participation of researchers from third countries to the research activities at any stage of the project is subject to the written approval of the funding agencies of both sides, irrespective of the research team they join.
